Alignment with SARE Legislation	Proposed projects must focus on Southern SARE's program objectives in developing sustainable agriculture systems or moving existing farming systems toward sustainability, as defined by Congress in the 1990 Farm Bill.	How well does the project align with SARE's legislated purpose?	Align the project with SARE legislation. This means an integrated system of plant and animal production practices having a site-specific application that will over the long-term: Satisfy human food and fiber needs, enhance environmental quality and the natural resource base upon which the agriculture economy depends, make the most efficient use of nonrenewable and on-farm resources, sustain the economic viability of farm operations, and enhance the quality of life for farmers and society as a whole.	10

List at least three (3) cooperating farmers in the project, who must confirm their participation. Each farmer listed must have a unique and detailed role. The educational materials should be useful in future trainings. It is appropriate to conduct small focused educational sessions or trainings using the materials to verify how successful they are and improve the approach as well as determine participation rates.
